# **ORDINANCE NO. 19-14**

# AN ORDINANCE ADOPTING A NEW SHADE TREE ORDINANCE FOR THE VILLAGE OF VERSAILLES, OHIO AND DECLARING AN EMERGENCY

**WHEREAS,** the Village of Versailles heretofore determined it was in the best interest of the inhabitants of the Village of Versailles to enact legislation for the regulation of the planting, maintenance and removal of trees in the public streets and rights-of-way, parkways and other Village-owned properties as originally set forth in Ordinance No. 94-51; commonly known as the Shade Tree Ordinance for the Village of Versailles; and

WHEREAS, the Village of Versailles Shade Tree Commission has over the years since its original enactment recommended certain amendments to be made to the Village's original Shade Tree Ordinance; and

**WHEREAS**, the Village of Versailles Shade Tree Commission has recommended to the Council of the Village of Versailles additional changes to the Village's current Shade Tree Ordinance; and

**WHEREAS**, the Council of the Village of Versailles has reviewed the latest proposed changes by the Shade Tree Commission to the Village's Shade Tree Ordinance and Council is of the opinion to adopt a new Shade Tree Ordinance incorporating all of the previous amendments and the latest proposed changes into a new Shade Tree Ordinance and such changes should take immediate effect.

NOW, THEREFORE, BE IT ORDAINED by the Village of Versailles, State of Ohio, as follows:

**SECTION ONE:** That a new Shade Tree Ordinance for the Village of Versailles as set forth in Exhibit A attached hereto and incorporated herein, be and hereby is adopted.

**SECTION TWO:** That said Shade Tree Ordinance set forth in Exhibit A cancel and supersede from its effective date all preceding ordinances or parts thereof in conflict therewith.

**SECTION THREE:** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety so as allow the revised provisions set forth therein take immediate effect and shall therefore be in full force and effect immediately upon its passage.

#### EXHIBIT A

#### AN ORDINANCE REGULATING THE PLANTING, MAINTENANCE, AND REMOVAL OF TREES IN THE PUBLIC STREETS AND RIGHT-OF-WAYS, PARKWAYS, AND OTHER VILLAGE OWNED PROPERTY; ESTABLISHING A SHADE TREE COMMISSION AS THE AGENCY PRESCRIBING REGULATIONS RELATING TO THE PLANTING, MAINTENANCE, AND REMOVAL OF TREES IN PUBLIC PLACES; AND PRESCRIBING PENALTIES FOR VIOLATIONS OF ITS PROVISIONS.

# BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF VERSAILLES, COUNTY OF DARKE, STATE OF OHIO:

**SECTION I.** This Ordinance shall be known and may be cited as the Shade Tree Ordinance of the Village of Versailles, Ohio.

**SECTION II.** For the purpose of this Ordinance, the following terms, phrases, words, and their deviation shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural include the singular, and words in the singular include the plural. The word SHALL is mandatory and not merely directory.

- A. <u>Village</u>: is the incorporated Village of Versailles, Ohio.
- B. <u>Person</u>: is any person, firm, partnership, association, corporation, company, or organization of any kind.
- C. <u>Street or Highway</u>: means the entire width of every public way or right-of-way when any part thereof is open to the use of the public, as a matter or right, for purposes of vehicular and pedestrian traffic.
- D. <u>Park</u>: shall include all public parks.
- E. <u>Public Places</u>: shall include all grounds owned by the Village of Versailles and public right-of-way.
- F. <u>Property Line</u>: shall mean the legal boundary line.
- G. <u>Lawn Strip or Curb Strip</u>: is that part of a street or highway right-of-way outside of the portion improved for travel, including the sidewalk.
- H. <u>Public Trees</u>: shall include all shade and ornamental trees, now or hereafter growing on any street, or public right-of-way, including lawn strip, or on any other public lands.
- I. <u>Large Trees</u>: are designated as those attaining a height of forty-five (45) feet or more.
- J. <u>Medium Trees</u>: are designated as those attaining a height of thirty (30) to forty-five (45) feet.
- K. <u>Small Trees</u>: are designated as those attaining twenty (20) to thirty (30) feet.
- L. <u>D.B.H.</u>: in forestry, diameter at breast height.
- M. <u>Property Owner</u>: shall mean the person owning such property as shown by the County Auditor's Plat of Darke County, State of Ohio.
- N. <u>Shade or Ornamental Tree or Shrub</u>: shall mean any and all woody vegetation.
- O. <u>Dripline</u>: shall mean the approximately circular vertical extension to the ground of the outer most branches and leaves of the tree as an indication of the spread of the root system.
- P. <u>Street Trees</u>: shall mean trees, shrubs, bushes, and all other woody vegetation on land lying between right-of-way lines of either side of all streets, avenues, or ways within the Village of Versailles.
- Q. <u>Park Trees</u>: shall mean trees, shrubs, bushes and all other woody vegetation in public parks having individual names, and all areas owned by the Village, or to which the public has free access as a park.

R. <u>Tree Topping</u>: shall mean the severe cutting back of limbs to stubs larger than three inches in diameter within the tree's crown to such a degree so as to remove the normal canopy and disfigure the tree.

# SECTION III. ESTABLISHMENT OF A SHADE TREE COMMISSION

A. There shall be created a commission to be known and designated as "Shade Tree Commission" which shall consist of five (5) members of the Village of Versailles, Ohio. Three (3) members shall be citizens and residents of the Village who shall be appointed by the Mayor with the approval of Council. The fourth member shall be a council member of the Village of Versailles. The fifth member shall be the Village Administrator.

The term of the three (3) persons of the Shade Tree Commission to be appointed by the Mayor shall have terms for three (3) years, except the term of members appointed to the first Commission shall be as follows: One (1) member for three (3) years, one (1) member for two (2) years, and one (1) member for one (1) year. In the event that a vacancy shall occur during the term of any member, his/her successor shall be appointed for the unexpired portion of said term.

- B. Compensation: members of the Shade Tree Commission shall serve without compensation, but shall be entitled to reimbursement for any and all necessary expenditures in carrying out the function of the Commission.
- C. The duties of said "Shade Tree Commission" shall be as follows:
  - 1. To study the problems and determine the needs of the Village of Versailles, Ohio, in connection with its tree planting program.
  - 2. To recommend to the proper authority, the type and kind of trees to be planted upon such Village streets or parts of Village streets or in parks as is designated.
  - 3. To assist the properly constituted officials of the Village of Versailles, Ohio, as well as the Council and citizens of the Village in the dissemination of news and information regarding the selection, planting, and maintenance of trees within the corporate limits on public property, and to make such recommendations from time to time to the Village Council as to desirable legislation concerning the tree program and activities for the Municipality.
  - 4. To provide regular and special meetings at which the subject of trees insofar as it relates to the Municipality may be discussed.
- D. That within a reasonable time after the appointment of said Commission and the approval of the members thereof, upon call of the Mayor, said Commission shall meet and organize by the election of a chairman and the appointment of a secretary. The said Commission shall then provide for the adoption of rules and procedures and for holding of regular and special meetings as said Commission shall deem advisable and necessary in order to perform the duties set forth.

# SECTION IV. AUTHORITY OF THE SHADE TREE COMMISSION

- A. The Shade Tree Commission shall have the authority to promulgate the rules and regulation of the Arboricultural Specifications and Standards of Practice governing the planting, maintenance, removal, fertilization, pruning, and bracing of street trees or trees upon public places in the Village, and shall direct, regulate, and control the planting, maintenance, and removal of all trees growing now or hereafter in any such stated area above within the Village of Versailles, Ohio. The Commission shall cause the provision of the Ordinance to be enforced.
- B. The Shade Tree Commission has the authority and jurisdiction of regulating the planting, maintenance, and removal of street trees and trees upon other public places to insure safety or preserve the aesthetics of such public sites, in accordance with the permit system contained in the terms of this ordinance. (Per ORD 15-33) The Shade Tree Commission designates the Village Administrator or his/her designated designee with authority on behalf of the Shade Tree Commission to authorize and approve the removal of trees within public areas of the Village of Versailles.
- C. Supervision: The Shade Tree Commission shall have the authority to affix reasonable conditions to the granting of a permit in accordance with the terms of this ordinance.
- D. Condition of Permit: The Shade Tree Commission shall have the authority to affix reasonable conditions to the granting of a permit in accordance with the terms of this ordinance.

- E. The Shade Tree Commissioner hereby designates the Village Street Foreman with the authority to authorize and approve the ordinary and customary trimming and pruning of trees in any public area of the Village of Versailles, Ohio. (ORD 15-21)
- F. Master Street Tree Plan: The Shade Tree Commission shall have the authority to formulate a Master Street Tree Plan. The Master Street Tree Plan shall specify the species of tree to be planted on each of the streets or other public places of the Municipality. From and after the effective date of the Master Street Tree Plan, or any amendment thereof, all planting shall conform thereto.
  - 1. The Shade Tree Commission shall consider all existing and future utility and environmental factors when recommending a specific species for each of the streets and other public places of the Village.
  - 2. Amend The Shade Tree Commission shall have the authority to amend or add to the Master Street Tree Plan at any time that circumstances make it advisable.

## SECTION V. PERMITS REQUIRED

- A. Planting, Maintenance, or Removal
  - 1. No person shall plant, preserve, prune, remove, cut above ground, or otherwise disturb any street tree or any tree on any public place without first filing an application and procuring a permit from the office of the Village Administrator. The person receiving the permit shall abide by the Arboricultural Specifications and Standards of Practice adopted by the Shade Tree Commission
  - 2. Application for permits may be obtained on-line or in person at the Village of Versailles Administration building. Completed applications must be filed at the Village of Versailles Administration building.
  - 3. Standards of Issuance: The Shade Tree Commission or its designated representative shall issue permits provided for herein if, in their judgment, the proposed work is desirable and the proposed method and workmanship thereof are of a satisfactory nature. Any permit granted shall contain a definite date of expiration and the work shall be completed in the time allowed on the permit and in the manner as therein described. Any permit shall be void if its terms are violated.
  - 4. Notice of completion shall be given within five (5) days to the Village Administrator for an inspection.
- B. Planting
  - 1. Application Data: The application required herein shall state the number of trees to be set out; the location, grade, species, cultivar, or variety of each tree; the method of planting; and such other information as the Shade Tree Commission shall find reasonably necessary to make a determination of whether a permit should be issued.
  - 2. Improper Planting: Whenever any tree shall be planted or set out in conflict with the provisions of this Section, it shall be lawful for the Shade Tree Commission to remove or cause removal of the same, and the exact cost thereof shall be assessed to the owner as provided by law in the case of special assessments.
- C. Maintenance
  - 1. Application Data: The application required herein shall state the number and kinds of trees to be sprayed, pruned, or otherwise preserved; the kind of treatment to be administered; the composition of the spray material to be applied; and such other information as the Shade Tree Commission shall find reasonably necessary to a fair determination of whether a permit should be issued.
- D. Removal, Replanting and Replacement
  - 1. Wherever it is necessary to remove a street tree or street trees from a lawn strip due to a Village of Versailles construction project, such as the replacement of a sidewalk, or the paving or widening of the portion of a street or highway used for vehicular traffic, the municipality shall bear the cost to replant such street trees or replace them provided that conditions outlined in the Shade Tree Ordinance do not prevent re-planting within the lawn strip.

2. No person or property owner shall remove a tree from the lawn strip or any public place for the purpose of construction, or for any other reason, without first filing an application and procuring a permit from the Shade Tree Commission or it's designee. Any replacement tree(s) shall meet the standards for size, and placement as provided for in the Shade Tree Ordinance. The property owner shall bear the cost of removal and replacement of all street trees removed subject to the Village's Tree Removal/Replacement Guidelines for any Non-Village construction projects.

## SECTION VI. TREE REPLACEMENT

- A. Eligibility for having a street tree replaced with the cost paid by the Village should be restricted to only those situations where such trees were removed due to a Village street construction project.
- B. Replacement street trees must be planted within the respective Right of Way or, in areas without a right-of-way, where original trees were located unless permission to relocate the trees to another area is granted by the Shade Tree Commission. (ORD 14-20)
- C. Any such replacement tree must be a type acceptable to the Village, as indicated on the Suggested Tree List. Under special circumstances a tree not listed may be planted, upon evidence given that such tree will not create problems to any Village improvement at the time such tree reaches its greatest height/crown spread.
- D. Such tree to be eligible for such replanting must have at least a 1<sup>3</sup>/<sub>4</sub>-inch diameter trunk size (D.B.H.), and be planted in accordance with the Shade Tree Ordinance Guidelines.
- E. Location of planting:

1. Should not be closer than:	Large Trees - 25 ft. to other trees
	Medium Trees - 20 ft. to other trees
	Small Trees - 15 ft. to other trees

- 2. Should not be closer than 6 feet to any water or sewer line, shut off valve, or meter pit.
- 3. Should not be closer than 25 feet to any street corner.
- 4. Should not be planted in any area where the tree at its full height may interfere with any aerial electric or telephone lines, UNLESS THE RESPECTIVE PROPERTY OWNER ENTERS INTO A WRITTEN AGREEMENT TO BE RESPONSIBLE FOR HAVING THE BRANCHES TRIMMED OUT OF THE WAY OF SUCH AERIAL LINES, WHEN NECESSARY.
- F. The Village shall participate in the payment of such tree or trees of an amount up to \$250.00 (including planting fee). The benefitting property owner shall be responsible for paying the difference; if applicable and for seeing to it that the tree is properly maintained from then on.
- G. The number of replacement street trees so eligible for Village participation shall not exceed the number of street trees removed along each property for such Village required street/sidewalk improvement project subject to the number being reduced by the spacing and location restrictions of Paragraph E.
- H. A valid invoice must accompany each reimbursement request.
- I. Property owners must apply for replacement trees within one (1) year after the Village mandated street or sidewalk improvement.

# SECTION VII. STREET TREES SPECIES TO BE PLANTED

The Suggested Tree List constitutes the official street tree species for the Village of Versailles, State of Ohio. No species other than those included in the list may be planted as Street Trees without written permission of the Village's Tree Commission. This list shall be reviewed and updated annually by the Tree Commission.

# SECTION VIII. SPACING

The spacing of the Street Trees will be in accordance with the three species size classes referred to in Section II of this Ordinance, and no trees may be planted closer together than the following: Small Trees - 15 feet; Medium Trees - 20 feet; and Large Trees - 25 feet, and no trees are to be planted closer than fifteen (15) feet to any public alley-way access; except in special plantings designed to approved by the Tree Commission.

# SECTION IX. DISTANCE FROM CURB AND SIDEWALK

The distance trees may be planted from curbs or curb lines and sidewalks will be in accordance with the three species size classes referred in Section II of this Ordinance, and no trees may be planted closer to any curb or sidewalk than the following: Small Trees - 1.5 foot; Medium Trees - 2.0 feet; and Large Trees - 2.5 feet except in special plantings designed or approved by the Tree Commission.

# SECTION X. DISTANCE FROM STREET CORNERS AND FIRE HYDRANTS

Except in special plantings designed or approved by the Tree Commission, no Street Tree shall be planted closer than 25 feet of any street corner, measured from the point of nearest intersecting curbs or curb lines. No Street Tree shall be planted closer than 6 feet to any fire hydrant. No Street Tree shall be planted closer than 25 feet to any public street intersection as to cause an obstruction to vision of any street sign or approaching traffic.

# SECTION XI. PUBLIC RIGHT-OF-WAY

No Street Tree shall be planted within any public right-of-way without an appropriately approved "Tree Planting Permit" issued by the Village within (60) days prior to planting.

## SECTION XII. UTILITIES

Unless approval is granted by the Tree Commission, no Street Trees other than those species referred to as Small Trees in Section II of this ordinance may be planted under or within 6 lateral feet of any overhead utility wire, or over or within 6 lateral feet of any underground water line, sewer line, shut-off valve, meter pit, distribution line, or other utility. Unless the respective property owner enters into a written agreement to be responsible for having the branches trimmed out of the way of such aerial lines, when necessary, when trimming is necessary to keep branches out of these overhead wires, trimming shall be at the owner's expense.

# SECTION XIII. PROHIBITED TREES

No type of Street Tree shall be planted that is prohibited by the Village due to problems of limb breakage, a tendency for the root system to clog sewers and drains, a tendency to attract insect pests, objectionable fruit toppings, a susceptibility to disease, a susceptibility to wind splintering, or problems of a surface root system breaking up concrete walks and curb sections located close in proximity. See attached Exhibit "A" for a list of Prohibited Trees. See attached Exhibit "B" for a Suggested Tree list.

#### SECTION XIV. PUBLIC TREE CARE

The Village shall have the right to plant, prune, maintain and remove trees, plants and shrubs within the lines of all streets, alleys, avenues, lanes, squares, and public grounds, as may be necessary to insure public safety or to preserve or enhance the symmetry and beauty of such public grounds.

The Village Tree Commission may remove or cause or order to be removed, any tree or part thereof which is in an unsafe condition or which by reason of its nature is injurious to sewers, electric power lines, gas lines, water lines, or other public improvements, or is affected with any injurious fungus, insect or other pest. This Section does not prohibit the planting of Street Trees by adjacent property owners providing that the selection and location of said trees is in accordance with all applicable section within this Ordinance.

#### SECTION XV. TREE TOPPING

No person, firm, or Village Department shall top any Street Tree, Park Tree, or other tree on public property; except, however, that a person or firm, who holds a grant of right-of-way by easement or otherwise, or a Village Department may prune or top such trees which might interfere with or endanger the safe and efficient operation of a service provided by such person, firm, or Village Department. Trees severely damaged by storms or other causes, or certain trees under utility wires or other obstructions where other pruning practices are impractical may be exempted from this Ordinance at the determination of the Village Tree Commission.

#### SECTION XVI. PRUNING, CORNER CLEARANCE

Every owner of any tree overhanging any street or right-of-way within the Village shall prune the branches so that such branches shall not obstruct the light from any street lamp or obstruct the view of any street intersection and so that there shall be a clear space of eight feet (8') above the surface of the sidewalk and a clear space of fourteen feet (14') (ORD 13-14) above that portion of a street outside the curb or that portion of a street or right-of-way subject to vehicular traffic. Said owners shall remove all dead, diseased, or dangerous trees, or broken or decayed limbs which constitute a menace to the safety of the public. The Village shall have the right to prune any tree or shrub on private property when it interferes with the proper

spread of light along the street from a street light or interferes with visibility of any traffic control device or sign.

# SECTION XVII. DEAD OR DISEASED TREE REMOVAL ON PRIVATE PROPERTY

The Village shall have the right to cause the removal of any dead or diseased trees on private property within the Village, when such trees constitute a hazard to life and property, or harbor insects or disease which constitute a potential threat to other trees within the Village. The Village Tree Commission will notify in writing the owners of such trees. Removal shall be done by said owners at their own expense within sixty days after the date of service of notice. In the event of failure of owners to comply with such provisions, the Village shall have the authority to remove such trees and charge the cost of removal on the owners property tax notice.

# SECTION XVIII. REMOVAL OF STUMPS

All stumps of street and park trees shall be removed below the surface of the ground to facilitate landscaping.

## SECTION XIX. OBSTRUCTION - TREES PRUNED

It shall be the duty of any person or persons owning or occupying real property bordering on any street upon which property there may be trees to prune in such manner that they will not obstruct or shade the street lights, obstruct the passage of pedestrians on sidewalks, obstruct vision of traffic signs, or obstruct view of any street or alley intersection. The minimum clearance of any overhanging portion thereof shall be eight (8) feet over sidewalks, and twelve (12) feet over all streets except truck thoroughfares which shall have a clearance of sixteen (16) feet.

#### A. Notice to Prune

Should any person or persons owning real property bordering on any street fail to prune trees as hereinabove provided, the Shade Tree Commission shall order such person or persons, within three (3) days after receipt of a written notice, to so prune such trees.

B. Failure to Comply

When a person to whom an order is directed shall fail to comply within the specified time, it shall be lawful for the Municipality to prune such trees, and the exact cost thereof be assessed to the owner as provided by law in the case of special assessments.

# SECTION XX. ABUSE OR MUTILIZATION OF PUBLIC TREES

Unless specifically authorized by the Shade Tree Commission, no person shall intentionally damage, cut, carve, transplant, or remove any tree; attach any rope, wire, nails, advertising posters, or other contrivance to any tree, allow any gaseous liquid or solid substance which is harmful to such tree to come in contact with them; or set fire or permit any fire to burn which such fire or the heat thereof will injure any portion of any tree located upon a public place.

## SECTION XXI. INTERFERENCE WITH THE SHADE TREE COMMISSION

No person shall hinder, prevent, delay, or interfere with the Shade Tree Commission while engaged in carrying out the execution or enforcement of this ordinance; provided, however, that nothing herein shall be construed as an attempt to prohibit the pursuit of any remedy, legal or equitable, in any court of competent jurisdiction for the protection of property rights by the owner of any property within the Municipality.

# SECTION XXII. PROTECTION OF TREES

All trees on any street or other publicly owned property near any excavation or construction of any building, structure, or street work, shall be guarded with a good substantial fence, frame, or box not less than four (4) feet high and eight (8) feet square, or any distance in feet from the tree equal to the diameter of the trunk in inches D.B.H., whichever is greater, and all building material, dirt or other debris shall be kept outside the barrier.

No person shall excavate any ditches, tunnels or lay any drive within a radius of ten (10) feet from any public tree without first obtaining a written permit from the Shade Tree Commission.

# SECTION XXIII. PLACING MATERIALS ON PUBLIC PROPERTY

No person shall deposit, place, store, or maintain upon any public place of the Village, any stone, brick, sand, concrete or other materials which may impede the free passage of water, air, and fertilizer to the roots of any tree growing therein, except by written permit of the Shade Tree Commission.

# SECTION XXIV. STREET TREE PLAN FOR NEW DEVELOPMENTS

That any new street developed in a subdivision by a private developer and dedicated to the Village shall have a street tree plan approved by the Tree Commission within the cooperation of the Street Committee and a bond posted, amount determined by the Shade Tree Commission with Council's approval for future installation of the plan. This requirement would be added to the list of subdivision regulations.

## SECTION XXV. TREE LOTTERY GUIDELINES

- A. Interested property owners should complete a lottery form and return it to the Village Administrator's Office by April 1. (One form per property owner.)
- B. Eligibility to participate in the lottery process will be subject to the following restrictions:
  - 1. Any owner of property within the Village, even if they reside outside of the village, are eligible to participate in the Tree Lottery (ORD 18-17).
  - 2. Property owners with nonexistent or deteriorated sidewalks (as defined in the Sidewalk Installation/Replacement Ordinance) will not be eligible to participate in the lottery.
  - 3. Property owners who fail to properly maintain either a replacement tree to lottery tree will not be eligible to participate in future lotteries.
  - 4. Property owners will not be eligible to receive a tree through the lottery process in two consecutive years.
  - 5. Property owners along a street that has been outlined in the Village's Five Year Capital Improvement Plan for reconstruction, will not be eligible to receive a tree through the lottery process.
- C. On or before May 31, the Tree Commission will randomly select ten (10) recipients and two alternates.
- D. All lottery trees must be planted within the corporation limits.
- E. All trees are subject to the Village's tree planting restrictions and will require a planting permit (no charge).
- F. A maximum of ten trees will be awarded in any given year.
- G. All decisions made by the Tree Commission are final.

## SECTION XXVI. MONARCH TREES

- A. The Village Council may designate any tree as a Monarch tree upon receiving a recommendation from the Tree Commission and determining that the tree is of exceptional value to the community because of unusual size, age, form, historical significance, or other demonstrable characteristic. Monarch trees may only be designated upon public places.
- B. Care of Monarch trees and trees upon public places:

The following protective techniques shall be followed during construction activity, which may impact the Monarch tree(s) upon public places:

- 1. Protect branch and trunk from equipment;
  - a. Fence vulnerable trees.
  - b. Move soil adjacent to trees by hand.
- 2. Prune carefully for vertical clearance;
  - a. Prune to minimum height required before construction.
  - b. Dress all significant pruning wounds.
- 3. Prevent injury from felling other trees;
  - a. Fell trees away from protected trees.

- b. Use control cables if fall is not predictable.
- 4. Avoid root damage during stripping of organic surface soil;
  - a. Avoid stripping of soil around trees in critical root zone.
  - b. Cut wood vegetation around trees at ground level. Do not pull out by equipment.
- 5. Minimize root damage during excavation for foundations;
  - a. Excavate by hand near major roots.
  - b. Prune roots by cutting individually.
- 6. Avoid injurious soil compaction by keeping storage and traffic out of critical root zone;
- 7. Prevent spills or waste disposal of paint, oil, fuel, and other soil contaminants;
  - a. Prohibit disposal in critical root zone.
  - b. Require immediate clean-up of accidental spills.
- 8. Control concrete washout;
  - a. Designate washout area away from trees.
  - b. Avoid runoff of washout to forested areas.
- 9. Control soil herbicides applied under sidewalk;

  - a. Use herbicide safe for use around trees.b. Do not exceed recommended concentrations.
- 10. Maintain surface drainage away from trees;
  - Where grades are modified, direct water away from trees. a
  - b. Do not permit ponding in critical root zone.
- 11. Control trenching for utilities drainage;
  - Coordinate trench locations with installation contractors. a.
  - Consolidate utility trenches. b.
  - Curve trenches, if necessary. c.
  - Tunnel under roots larger than 1" in diameter when feasible. d.
- 12. Control grading in scalifying operations;
  - Excavate no more than 6" below finish grade. a
  - Add topsoil to achieve finish grade. b.
- 13. Minimize thinning or removing of undergrowth;
  - Save clusters of trees when working with species which function poorly in the open or as singles.
  - As much as possible, save existing undergrowth. b.
- 14. Protect from damage:
  - Do not permit construction of recreational fires within 100' of protected trees. a.
  - Do not permit raising of buildings by fire if within 100' of protected trees. b.
- C. Authorized Pruning or Trimming of Monarch Trees:

The following abuse or mutilation of protected monarch trees shall be prohibited:

- No person shall intentionally damage, cut, carve, or otherwise disfigure any monarch tree 1 designated by the Tree Commission and Village Council other than as permitted by the arboricultural specifications and standards of practice adopted by the Tree Commission.
- 2. No person shall attach any rope, wire, nail, poster, or other contrivance to any tree, except that the Village Tree Commission may authorize the use of cables on a monarch tree if it is determined by the Tree Commission the use of cables would preserve the life of the monarch tree.
- 3. No person shall allow any substances harmful to vegetation to be improperly applied to any tree.
- No person shall set fire to or permit a fire to burn in an area within 100' of any monarch 4. tree.

# SECTION XXVII. VIOLATION AND PENALTY

Any person, firm or corporation violating or failing to comply with any of the provisions of this Ordinance shall be guilty of a minor misdemeanor and when convicted shall be fined for the first offense not more than One Hundred Dollars (\$100.00) and costs; and for the second offense within one (1) year, not more than Two Hundred and Fifty Dollars (\$250.00) and costs. In addition, the person shall replace the tree with a size and species recommended by the Tree Commission within sixty (60) days after the date of service of notice to replace is given by the Village Tree Commission. The cost of the removal, replacement tree, and planting expenses shall be paid by the person violating this ordinance. In the event of the failure of the person to comply with such provisions, the Village shall have the authority to replace the tree and charge all costs provided herein on the owner's property tax notice. Each tree affected by a violation of this ordinance shall constitute a separate offense.

**SECTION XXVIII.** This ordinance shall take effect and be in force from and after the earliest period allowed by law.

**SECTION XXIX.** That the Clerk of the Village Council be and hereby is authorized and directed to cause publication of this ordinance to be made in a manner as provided for according to law.

# SUGGESTED TREE LIST (updated ORD 16-10)

# SMALL TREES

Less than 30 feet high at maturity; recommended planting strip should not be less than 2 feet wide.

**Flowering Crabapples** (Spring Snow, Centurion, Harvest Gold, Madonna, Velvet Pillar, Adirondack varieties)-abundant flowers in spring, small fruits in fall.

**Golden raintree**-feathery, light green foliage. Large clusters of bright yellow flowers emerge in July. **Trident Maple**-brilliant red fall color, compact head of small, shiny leaves.

Hedge Maple-small leaves, single trunk tree.

Leprechaun Ash - leaves turn yellow in the fall.

Pacific Sunset Maple - leaves turn orange-red in the fall.

#### MEDIUM TREES

Less than 45 feet high at maturity; recommended planting strip should not be less than 3 feet wide.

**Hawthorn** (Washington and Winter King varieties)-white flowers in spring followed by small red fruits persisting through winter.

**Little-Leaf Linden-**small dense, dark green foliage and inconspicuous small, fragrant flowers in June; Gieneven and Greenspice varieties recommended.

**Red Maple** (cultivated varieties)-well-formed tree produced colorful, fall foliage. Armstrong is narrow formed; Red Sunset and October Glory varieties are broader in form.

Hop Hornbeam-slow growing with dense elm-like foliage; bark peels in thin strips for an attractive appearance.

Crimson Maple - leaves are crimson/maroon and do not change color in the fall.

## LARGE TREES

Exceeding 45 feet high at maturity; recommend planting strip should not be less than 4 feet wide.

**Thornless Honeylocust** (Imperial, Shademaster, Halka and Skyline varieties)-graceful, spreading variety casts light shade; no leaf problem.

Red Oak-massive tree with broad top; relatively fast growing.

**Black Tupelo-**a pyramid upright tree produces beautiful, fall color; grows well in poorly drained, moist soils.

**Sweetgum-**a broadly pyramidal tree with star-shaped leaves that turn bright scarlet in autumn; interesting corky bark.

**London Plane-**a vigorous, quick growing tree with a tall, straight trunk, flaky bark is light-colored underneath.

Silver Linden-a spreading upright tree with leaves that appear two-tone in autumn.

Sugar Maple-broad, round-headed shade tree provides beautiful fall color.

Bald Cypress-deciduous conifer widely adaptable to city conditions.

Slender Silhouette Sweetgum-grows quickly to form tall, narrow, column. Good visual screen.
