2. Service will be constructed from the Village water main to curb shut-off valve by the Village if not already in place to the connecting property. The owner of the property is responsible to plumb the meter inside the structure by the Village and install the service line from the curb valve to the meter at their expense. Meter pits are prohibited for new construction unless otherwise approved by the Village. The owner must install a quarter-turn shut-off valve on both sides of the meter for draining.
3. A backflow prevention device is required for all industrial, commercial, and institutional customers. Any residential customer with any other pressurized water source entering the building or any potential for hazardous cross-connections, as determined by the Village, must install an approved backflow prevention device. Backflow devices shall be tested annually by a certified technician licensed in the State of Ohio with a report provided to the Village.
4. Rules and regulations related to water service is outlined in Village Ordinance No. 17-20.
5. All water services shall adhere to Village of Versailles construction standards and drawings.
6. The customer is required to obtain all necessary plumbing and building permits prior to construction of the service.

The property owner/customer is responsible install the sanitary sewer lateral from the right-of-way or easement line to the structure at their expense. A sanitary sewer lateral cleanout is required outside of the foundation wall of the structure and a clean-out is required at the right-of-way or easement line.

- All sanitary sewer service laterals shall adhere to Village of Versailles construction standards and drawings.
- The customer is required to obtain all necessary plumbing and building permits prior to construction of the service.
