

ADVERTISEMENT FOR BIDS

1. Sealed Bids for Versailles, Ohio "McGreevey Road Substation Construction" will be received by the Village of Versailles, Ohio, at the office of the Village Administrator, 177 North Center Street, Versailles, Ohio 45380-0288 until **2:00 PM, Local Time, March 19th, 2026** and at that time and place will be publicly opened and read aloud.
2. The proposed Work consists of furnishing all labor, supervision, tools, materials and equipment to complete the project scope as follows:

The Village is seeking proposals for the construction of a new 69 kV to 12.47 kV McGreevey Road Substation. The new substation will consist of the following major equipment that will be furnished by the Village to be installed by the contractor: (1) 69kV-12.47kV power transformer, lot of 15kV Structures, Bussing and Switching, (1) 15kV Vacuum Circuit Breaker, (3) 15kV Vacuum Circuit Reclosers, (9) 416.3kVA Voltage Regulators, (3) Relay and Control Panels. The contractor shall furnish all labor to install the Village furnished equipment; and the contractor shall furnish and install all other material and labor to provide for a complete substation as listed in the specifications and as shown on the contract drawings.

3. The contract documents and Specifications are on file at the office of the Village Administrator, 177 North Center Street, Versailles, Ohio 45380-0288, and at the office of the Engineer, GPD Group, 520 South Main Street, Suite 2531, Akron, Ohio 44311-1010. Contract Documents and Specifications are available in PDF format and can be sent via e-mail. A hardcopy set may be obtained by sending a non-refundable check for \$40.00 to the Engineer's Office, attention Ashley Howerter. Interested parties must contact the Engineer's Office to be a registered bidder. Only proposals submitted by registered bidders will be accepted.
4. All bids shall be signed and submitted in duplicate on the proposal form blanks, which are provided separately with the Specifications. Bids shall state the price by item and shall be enclosed in a sealed envelope marked (electronic submittals will not be accepted): **Bid for Versailles, Ohio McGreevey Road Substation Construction** and addressed to the attention: **Village Administrator, 177 North Center Street, Versailles, Ohio 45380-0288.**
5. Each bid shall contain the name of every person, firm or corporation interested in the same, and must be accompanied by either a bid guaranty bond to the satisfaction of the Village, or a certified check drawn on a solvent bank, in the sum of 10% of the bid, made payable to the Village of Versailles, Ohio, as a guaranty that if the bid is accepted, a contract will be entered into and its performance properly secured.
6. The Village of Versailles, Ohio, reserves the right to reject any or all bids and to waive any irregularities in bidding.
7. A Pre-Bid meeting is scheduled for February 19th, 2026, at 2:00 pm at Village Hall, 177 North Center Street, Versailles, Ohio 45380-0288.

8. No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.
