1. Sealed Bids for Versailles **"McGreevey Road Substation – Major Equipment"** will be received By the Village of Versailles, Ohio at the Office of the Village Administrator, 177 North Center Street, Versailles, Ohio 45380-0288 until

2:00 p.m. Local Time

and at that time and place will be publicly opened and read aloud.

2. The proposed Work consists of furnishing the following equipment and materials:

Bid Item No.1: One (1) 12/16/20MVA, 69kV-12.47kV Power Transformer
Bid Item No.1A: One (1) 15/20/25MVA, 69kV-12.47kV Power Transformer
Bid Item No.2: 15kV Structures, Bussing and Switching
Bid Item No.3: One (1) 15kV Vacuum Circuit Breaker
Bid Item No.4: Four (4) 15kV Vacuum Circuit Reclosers
Bid Item No.5: Ten (10) 416.3kVA Voltage Regulators
Bid Item No.6: Three (3) Relay and Control Panels

3. The contract documents and Specifications for the project will be available at the office of the Engineer, GPD Group, 520 South Main Street, Suite 2531, Akron, Ohio 44311-1010. You must contact the Engineers Office to be a registered bidder. Only proposals submitted by registered bidders will be accepted.

4. All bids shall be signed and submitted in duplicate on the blanks, which are provided separately with the Specifications. Bids shall state the price by item and shall be enclosed in a sealed envelope marked:

5. Bidders must use the printed forms provided in the bidding document therefore, as none other will be accepted. Each proposal must contain the full name of the party or parties making the same, and all parties interested therein and must include a notarized non-collusion clause.

6. Bidders may submit proposals for just one (1) Bid Item or any combination of Bid Items.
7. The bid shall be accompanied by a bid bond in accordance with the Ohio Revised Code 153.54, redeemable by the Village of Versailles, Ohio for ten percent (10%) of the total amount of the bid as a guarantee that if the bid is accepted, a contract will be entered into.

In lieu of a "bid bond," a certified check, on a solvent bank, made payable to The Village of Versailles, in the sum of ten percent (10%) of the total amount of the bid will also be accepted as a guarantee that if the bid is accepted, a contract will be entered into.

8. The successful bidder will be required to post a Performance-Payment Bond in the amount of one hundred percent (100%) of the total amount of the contract awarded.
9. No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.
10. The Village of Versailles, Ohio reserves the right to reject any or all bids and to waive any irregularities in bidding.
