Example: Excavation of an 8' x 12' area in a 4 year old street
 \$900 for the first 20 square feet of excavation
 96 sq. ft. - 20 sq. ft. = 76 sq. ft.
 76 sq. ft. x \$45 per sq. ft. = \$3,420
 \$3,420 + \$900 = \$4,320 total payment

Example: Excavation of an 3' x 100' area in a 5 year old street
\$8,000 for the first 200 square feet of excavation
300 sq. ft. - 200 sq. ft. = 100 sq. ft.
100 sq. ft. x \$40 per sq. ft. = \$4,000
\$8,000 + \$4,000 = \$12,000 total payment
