

ORDINANCE NO. 19-38

AN ORDINANCE REVISING THE RATES FOR THE COLLECTION OF REFUSE  
WITHIN THE VILLAGE OF VERSAILLES, OHIO

WHEREAS, the Village of Versailles provides and has been providing refuse collection and disposal services for the residents and businesses located within the Village of Versailles; and

WHEREAS, the Village Council did, pursuant to Ordinance No. 08-22, create Chapter 907 of the Village Code providing for the policies and procedures with respect to the provision of such refuse services which Ordinance did further provide that the rate for the provision of said refuse service be established by a separate ordinance; and

WHEREAS, the Village did heretofore establish various rates for such refuse services pursuant to Ordinance No. 87-23; which ordinance has been previously modified by the Village pursuant to Ordinances 89-5, 95-29, 98-45, 08-29 and 15-11; and

WHEREAS, due to the increased cost that the Village has incurred in providing refuse services to its residents and businesses, Council is of the opinion that it has become necessary to once again increase the rates for the refuse services provided by the Village;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Versailles, Ohio as follows:

**SECTION ONE:** That Ordinance No. 08-29, Section One, be revised as follows:



**SECTION TWO:** That the above rate changes shall be effective with the bills due December 10, 2019.





VILLAGE REFUSE RATES

The following monthly rates are hereby established for Village collection of refuse, trash, and garbage generated on properties within the Village corporation limits:

1. Residential Container Rate per month

A. 35 Gallon \$16.50, 65 gallon \$17.50, 95 gallon \$18.50

B. Commercial Rate..... Based on the following schedule:

Fee for LARGE items will be \$10.00 per item and will require a large item tag (purchased prior to pick up) from the Village Administrative Office. Large items are any item too large to fit within the provided refuse container.

Fee for items requiring the Refuse truck driver to exit the vehicle for hand pick up of items small enough to fit in the Village provided container will incur a \$5.00 charge in addition to the monthly container charge.

2. Rental Dumpsters are available for a 2 week period. There will be a minimum one time charge regardless of use.

A. 2 Yard Dumpster - \$45.00      B. 3 Yard Dumpster - \$65.00
